## MEETING CALLED TO ORDER

**1b) Mayor Thul welcome everyone**

**1c) Approve Minutes for Budget Meeting April 27, 2016 and May 11, 2016.** Councilor Crampton moved Councilor Stephens second to approve Budget Meeting minutes and Council Meeting minutes all in favor none opposed

### **2) Correspondence:**

**4a) Approve Resolution 16-40 Red Flag:** Councilor Crampton motioned Councilor Stephens second to approve Resolution 16-40 Red Flag all in favor none opposed

**4b) Approve Merging Parks & Recreation with WCDC:** Councilor Harral motioned Councilor Crampton second to approve Merging Parks & Recreation with WCDC all in favor none opposed.

**4c) Approve City Recorder to Attend LOC Class:** Councilor Stephens motioned Councilor Harral second to approve the City Recorder to attend LOC class all in favor none opposed

**4d) Approve New Sewer Rate:** Mayor Thul discussed the reasons why the city needs to increase the sewer rate. Council felt it was the only option the city had. Mayor Thul moved Councilor Harral second to approve the new sewer rate *from* \$57.50 to \$62.50. All in favor none opposed.

second; RS, TC and SH in favor, none opposed. Mayor Thul recused himself  
from paying Athena Auto Parts bill, the owner is his son. Councilor Crampton  
made the motion Councilor Harral second to pay Rick Stephens reimbursement  
check all in favor DT, TC & SH. None opposed. *Councilor Stephens recused  
himself.*
